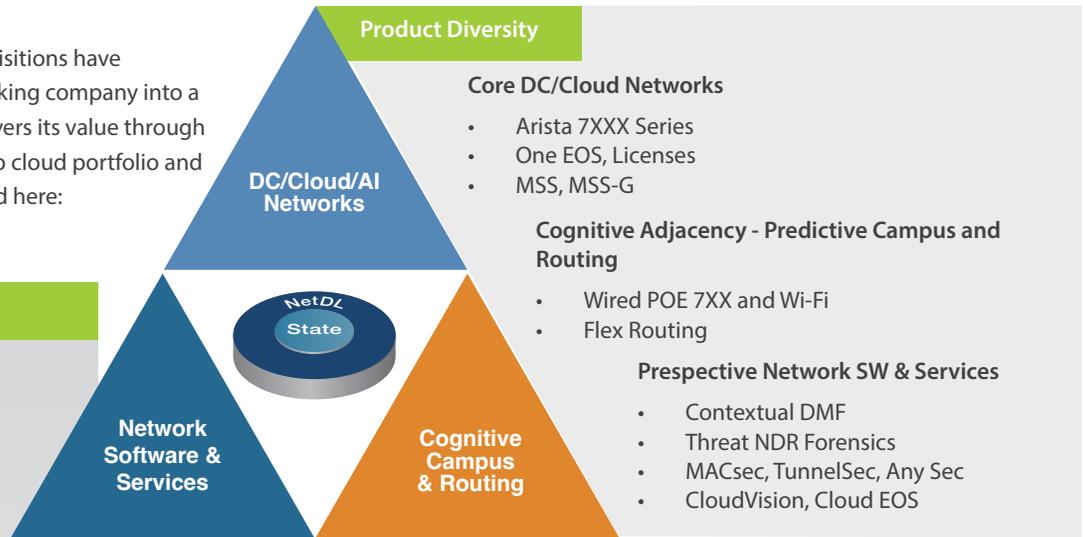

#### First Product Releases

- 2004** - The company was founded with a vision to revolutionize high-speed Ethernet at massive scale.
- 2008** - Launched Arista EOS® (Extensible Operating System) and shipped its first commercial switching product.
- 2010** - The company shipped its first modular spine product, the award-winning Arista 7500 Series, which was introduced as a revolutionary switching platform that maximized data center performance, efficiency, and overall network reliability.
- 2014** - The company had its initial public offering on the New York Stock Exchange under the symbol ANET. Two million ports shipped to date.
- 2015** - Introduced Arista CloudVision®, pioneering a modern network operating model across enterprises.
- 2016** - Released the 3rd Generation 7500R, achieving one million routes and five million cumulative ports shipped.
- 2017** - Launched Arista "Any Cloud" with vEOS Router for flexible multi-cloud connectivity.
- 2018** - Introduced first Campus Switching Products. Acquired Mojo Networks and Metamako; surpassed 20 million cumulative ports shipped.
- 2019** - Introduced 400G and Cloud EOS Any Cloud, advancing network performance and scalability.
- 2020** - Acquired Big Switch Networks and Awake Security and achieved the #1 market position in the 100/200/400G ports market.
- 2021** - Launched AI/ML-driven AVA security; reached 50 million cumulative ports shipped.
- 2022** - Acquired Untangle and Pluribus Networks. The company introduced Arista CUE (Cognitive Unified Edge), a cloud-managed solution consolidating networking and security functions and 400/800G AI Networking solutions, expanding AI-driven data handling capabilities.
- 2023** - Entered the WAN Routing market; achieved 75 million cumulative ports shipped.
- 2024** - Celebrated the 20th anniversary of the company, 10th IPO anniversary, and the milestone of 10,000 customers. Reached 100 million ports installed globally and attained the #1 market share in data center switching. Launched Smart Etherlink™ 800G AI platforms, marking Ethernet as the de facto standard for the AI Center.
- 2025** - In July of 2025 Arista expanded its AI-driven campus and branch networking offerings and acquired the VeloCloud SD-WAN portfolio from Broadcom. This combination of innovations will bring operational ease through zero touch operations, proactive monitoring, and automated troubleshooting across the broad set of client-to-cloud networking domains.
